

PLANNING AND ZONING COMMISSION MEETING
January 5, 2015
MINUTES

I. CALL THE MEETING TO ORDER

The meeting was called to order at 6:00 p.m. with Ann Miller, Chairman presiding. Board members present: Elizabeth Bebe, Ann Miller, Connor Brown, Tom Mannering, and Alana Seaman. City of Ingleside staff present: Chief Building Official John Davis, Code Enforcement Officer Carey Dietrich and Administrative Assistant Cassandra Duvall.

- II. Election of a Chairman and Vice-Chairman of the Planning and Zoning Commission for the 2015 year. Board Member Connor Brown nominated Ann Miller to serve as the Chairman which was seconded by Board Member Elizabeth Bebe. The nomination was approved unanimously. Board Member Elizabeth Bebe made a nomination to appoint Connor Brown as Vice Chairman which was seconded by Board Member Tom Mannering. The nomination was approved unanimously.

(A) Public Hearing concerning an application filed by Rockland Development, to rezone Lot 1 Rockland Development Addition also known as 2905 Rockland Boulevard. Rockland Development is requesting to be allowed to change the zoning from its present classification of C-1 (Local Commercial) and R-1 (Single-Family Residential) to C-2 (General Commercial).
