

A RESOLUTION OF THE CITY COUNCIL OF INGLESIDE, SAN PATRICIO COUNTY, TEXAS, APPOINTING/REAPPOINTMENT OF MEMBERS TO THE BOARD OF ADJUSTMENTS.

WHEREAS, Tracy Long, Frank Truitt, Ronnie Benton & Gary Patton have expressed a desire and willingness to serve on the Board of Adjustments for a second term.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF INGLESIDE, TEXAS, THAT:

- Section 1.** The matter and facts recited in the preamble hereof are found and determined to be true and correct.
- Section 2.** Kelly Shepperd is continuing to serve his/her second consecutive term as a Member to the Board of Adjustment, Position 1, with his/her term beginning on January 1, 2021 to December 31, 2022.
- Section 3.** Theresa Finch is continuing to serve his/her second consecutive term as a Member to the Board of Adjustment, Position 2, with his/her term beginning on January 1, 2021 to December 31, 2022.
- Section 4.** Diane Brady is continuing to serve his/her second consecutive term as a Member to the Board of Adjustment, Position 3, with his/her term beginning on January 1, 2021 to December 31, 2022.
- Section 5.** Tracy Long is appointed to serve his/her second consecutive term as a Member to the Board of Adjustment, Position 4, with his/her term beginning on January 1, 2022 to December 31, 2023.
- Section 6.** Frank Truitt is appointed to serve his/her second consecutive term as a Member to the Board of Adjustment, Position 5, with his/her term beginning on January 1, 2022 to December 31, 2023.
- Section 7.** Ronnie Benton is appointed to serve his/her second consecutive term as an Alternate Member to the Board of Adjustment, Position 6, with his/her term beginning on January 1, 2022 to December 31, 2023.
- Section 8.** Gary Patton is appointed to serve his/her second consecutive term as an Alternate Member to the Board of Adjustment, Position 7, with his/her term beginning on January 1, 2022 to December 31, 2023.
- Section 9.** Mike Francesco is continuing to serve his/her first consecutive term as an Alternate Member to the Board of Adjustment, Position 8 with his/her term beginning on January 1, 2021 to December 31, 2022.
- Section 10.** Tom Mannering is continuing to serve his/her second consecutive term as an Alternate Member to the Board of Adjustment, Position 9, with his/her term beginning on January 1, 2021 to December 31, 2022.
