

RESOLUTION 2021 - 55

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF INGLESIDE, SAN PATRICIO COUNTY, TEXAS, CONFIRMING THE APPOINTMENT/REAPPOINTING OF OFFICERS TO THE INGLESIDE VOLUNTEER FIRE DEPARTMENT**

**WHEREAS**, the Ingleside Volunteer Fire Department (IVFD) was created by City Code of Ordinances Article III, Section 42-56; and

**WHEREAS**, the City Code of Ordinances Article III, Section 42-57 allows for the election of a Chief for a two (2) year term and all other Officers for one (1) year terms; and

**WHEREAS**, at this time an election was held in December 2020; and

**WHEREAS**, the Fire Chief for the IVFD is a two year term that does not expire until December 31, 2022; and

**WHEREAS**, the Assistant Chiefs and Captain positions are 1 year terms; and

**WHEREAS**, whereas the new terms will be from January 1, 2022 to December 31, 2022; and

**WHEREAS**, the existing IVFD Membership have voted the appointment/reappointment of Assistant Chief – Jacob Atcher, Assistant Chief – Larry Norotsky, Captain – John Witt, Captain Robert Puig and Captain Adrian Rodriguez; and

**WHEREAS**, Jacob Atcher, Larry Norotsky, John Witt, Robert Puig and Adrian Rodriguez have expressed a desire and willingness to serve as Officers to the IVFD.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF INGLESIDE, TEXAS THAT:**

- Section 1.** The matter and facts recited in the preamble hereof are found and determined to be true and correct.
- Section 2.** Jacob Atcher is reappointed to serve as Assistant Fire Chief for the IVFD with a term of January 1, 2022 to December 31, 2022.
- Section 3.** Larry Norotsky is reappointed to serve as Assistant Fire Chief for the IVFD with a term of January 1, 2022 to December 31, 2022.
- Section 4.** John Witt is reappointed to serve as Captain for the IVFD with a term of January 1, 2022 to December 31, 2022.
- Section 5.** Robert Puig is reappointed to serve as Captain for the IVFD with a term of January 1, 2022 to December 31, 2022.
- Section 6.** Adrian Rodriguez is reappointed to serve as Captain for the IVFD with a term of January 1, 2022 to December 31, 2022.
